OVERVIEW

The lawsuit claims that the Defendants conspired to fix and raise the price of broiler chicken through production cuts and other means. They coordinated their output, limited production, with the intent and expected result of increasing prices of Broilers in the U.S., in violation of federal antitrust laws.

FREQUENTLY ASKED QUESTIONS

1. A lawsuit sounds complicated. Why should I participate?

This is not a lawsuit. Once the preliminary settlement has been approved by the court, settlement funds are set aside by the defendants and are available to be distributed. We encourage all eligible companies to claim their share as refunds could be significant depending on the size of your claim. Only companies who file a claim will receive a refund. We are leading experts in claims filing, valuation and refund recovery and can help manage the entire process with minimal time commitment from you.

2. Is my information confidential?

The court appointed Claims Administrator is bound to keep your information, including your company name and all proprietary data, totally confidential. The agreement you sign with CCA also requires us to keep your data confidential and we only use your information to file your claim or for evaluating eligibility in future settlements.

3. I'm busy. How much time will this take and what information do I need to provide?

We have two primary objectives - 1. Minimize the amount of time our clients have to spend on preparing the claims package, and 2. Maximize the recovery for our clients.
